In early January 2019, after almost a year of misdiagnosis, my mum, Lyn, was diagnosed with tongue cancer and our world turned upside down. Many of you will know my mum for being full of life and always planning her next adventure somewhere in the world. This is an unfair and unjust diagnosis and one that we still struggle to come to terms with.

Aggressive chemotherapy and radiotherapy has been more of a challenge than we were expecting but she faces every day with more strength and determination than the one before. She is without a doubt the strongest, most inspirational woman I've ever met and she's shaped my entire life in a wonderful way.

Throughout these tough times, my family and I have used the services offered by the **Big C** regularly. Whether that is having a cup of tea and a chat with others on the same journey, complementary treatments such as reflexology for mum or counselling for me, they have been truly incredible. Somebody is always there with a warm smile and a sympathetic ear, and they've made this whole situation that little bit more bearable.

## 5.3 Umpire Secretary

Libby said it had been very difficult to get enough umpires for all the matches as there was simply not enough for various reasons. The committee have come up with a proposal to address this which will be discussed in item 6. Libby thanked all of the umpires that had covered, especially at short notice. Well done to Chloe Lambert, Eleanor Shulver, Rian Martin and Aisha Zaman who have all passed their Into Officiating Award. Also congratulations to Debbie Smith who passed her C Award earlier in the season.

## 6. Latest League Minutes

The minutes from the latest committee meeting was discussed. Please see attached minutes from the latest committee meeting which was held on Monday 18<sup>th</sup> March 2019.

Item 1- no questions/issues arising.

Item 2- Teams voted in that players have 30 seconds after time is called to assess whether they need to go off. If after 30 seconds the player needs more time then she will need to leave the court in accordance to Injury Time rules.

Item 3- no questions/issues arising.

Item 4- As part of the proposal for all teams to have two umpires by 2020 several umpires volunteered to attend a mentoring workshop, to be held soon. If players are interested in becoming an umpire they can contact Libby for the next available course. It was suggested that maybe some friendly matches could be arranged so that players can have a go at umpiring before they commit to attending a course. They could be buddied up with a qualified umpire.

Item 5- All umpires agreed for Janice to have their numbers as she is not on the What's App group.

Item 6- A Facebook Poll will be put on the Lowestoft Netball Page so players can vote whether they want a tournament which they can enter as a team or as individuals.

## 7. Summer League – Schedule, Handicap, Points & Times

After a long discussion it was agreed by teams that they would like to go with Babs suggestion. This will be based on final winter league positions, plus new teams. Teams will be divided into two mixed sections (which will include a 3+ handicap depending on where the teams finished in the winter league) e.g Section A will include teams that finished 1<sup>st</sup>, 3<sup>rd</sup>, 5<sup>th</sup>, 7<sup>th</sup>, 9, 11<sup>th</sup> etc. The teams in each section play each other in a round robin. Points are awarded as in winter league. Once all matches have been played teams are given a finishing position to create two new sections e.g the top four teams from the two sections combine to make section C and the bottom three teams of each sections combine to make a section D. These teams then play each other in a round robin to get a final summer league finishing position. Babs and Nicola will meet to plan out fixtures. Once this has been completed and umpires have been organised teams will be notified. The committee envisage that Summer Fee costs will be around £100. This will be confirmed once the fixtures are confirmed.

## 8. AOB

Prizes- It was agreed by teams that they would still like to receive a prize for winning the league/fair player.

Complaint from Lynn Grove School regarding noise levels/honking of horns whilst on the school premises. Committee reminded teams to be considerate of the neighbours as the school is in a residential area.
