### **1. Welcome from Chairman**

Sharon welcomes everyone and thanked them for making an effort to attend. She started off discussing the Summer and Winter League and acknowledged that both had been a success with no major issues. She spoke about the new format for the summer league (round robin) that was trialled last year and how it had been a success. The committee had lots of positive feedback with regards to this; therefore this format will be used again this summer.

Sharon highlighted that the only issue this year with regards to the winter league was some bad weather (although not as bad as previous years). Following on from this EPA had tried to cancel the games without a member of the committee checking the courts first. However after an inspection the committee decided that the courts were safe to play on. Sharon acknowledged the hard work of the committee and thanked them for ensuring the league continued to run smoothly without any issues. Lastly she thanked all the umpires and scorers as without them the league would not run.

All fixtures were played. No issues. Results were published in the local paper weekly.

## **Umpiring Secretary**

There have been no issues during the year and all games have been covered, thanks to the willingness of umpires to over each other when required.

We currently have 23 practising umpires in the league with only one team who needs to gain a qualification during the next year.

An umpire meeting was recently held and Sophie Pike from Norfolk attended to answer any rule queries. Congratulations to the following umpires who have passed awards during the year-

C Award – Emma Warnes & Jane Temple (Solebay)

Beginners - Louise Taylor (Stewarts)

Umpiring courses are always advertised on the website and the Beginner Award courses are normally held twice yearly and C courses once.

The Beginner Award lasts for 4 years and can be re-taken once after that. It is expected that umpires will progress on to their C Award within this time.

The C Umpiring Award currently does not expire.

The testing now includes a fitness (bleep) test as well as a written and practical test.

Scorers –it was suggested at the recent umpire meeting that some guidelines are put together and made available on the website for all teams.

## **Website**

## 5. **Unaffiliated Players Proposal**

Previously under the England Netball insurance, any unaffiliated player would affect all the players within the game, including umpires, as their insurance was no longer valid while the unaffiliated player was on court.

This has now changed and each player is covered whether they are playing with affiliated or unaffiliated players, therefore the committee wish to propose that a new player could play twice for a team before they had to be affiliated. (See attached sheet for more details) A vote was put to the teams as to whether they wanted to see this happening in the league. All teams felt that this was a good idea.

The committee suggested that teams could play up to 6 unaffiliated players for the netball year (summer and winter). Some teams queried whether this was too much. A vote was put to the teams. The majority voted for 6. Other concerns that were raised were teams worrying about their insurance being invalid if they were injured by an unaffiliated player. As already stated in the proposal we assured them that this would not be the case. Teams asked what would happen if the new player was dangerous on court to which the committee assured them that the umpire in charge of the game would not let dangerous play go ahead and that teams could take that player off if they were not up to standard.

## 6 **Election of Committee**

Karen Daniels has stepped down as fixtures secretary due to injury and not returning to netball. The committee has one volunteer who would like to join. Nicky Caswell was proposed and seconded and voted onto the committee.
